INSTRUCTIONS FOR REGISTRATION OF USERNAME AND INITIAL LOG-IN IN THE DEPOSITORY'S DISTRIBUTION SYSTEM

1. It is recommended that the e-mail address of the holder should be used as a username, which was previously given in this Application Form.
2. If you are legal entity which besides holder's user profile has opportunity to open a user profile as an issuer as well, please note that the e-mail addresses used for activation, and the usernames for the holder's account and issuer's account, should be different for these two types of user profiles.
3. An activation link will be sent to the e-mail address given in this Application Form, which will be used for activation of the user profile (the activation link is available within 7 days after the registration). The user profile will be activated right after you have accessed the activation link.
4. Immediately after the activation of the user account you will be redirected to the password generator page. The password that is going to be created by you has to be a complex password that has to contain at least 6 characters, a combination of small and capital letters, as well as special characters (e.g.!"#\$%&'()*+,-./:;<=>?@[\\]^_`{|}~).
5. Once you have successfully created the password for your user profile, you can approach to the Depository's Distribution system.
